There will be a limit to the number of vendors within a category. Your art or craft must be HAND-CRAFTED, ARTIST

CREATED ITEM, and if accepted you may only sell in the category for which you applied and were juried in. If you are selling jewelry, be sure to specify the type, e.g. fused glass, lamp work, fine silver, fiber jewelry, polymer beads, etc.

All vendors must submit at least 3 photos of different work which will be sold. The photos must be of good quality and clear. Photos on printer copy paper and emailed photos will not be accepted.

There is a limit of one space per vendor. Spaces are 6'x6' and 8'x6'.

In addition, there will be a 10% commission on all sales made (not including tax). This commission will be collected by FASA at the end of the show.

THIS IS A JURIED SHOW, AND ALL DECISIONS OF THE JURORS ARE FINAL. THEREFORE, FASA MEMBERS, OR PRIOR VENDORS AT A FASA EVENT ARE NOT GUARANTEED ACCEPTANCE.

Acceptance as a vendor will be based on, but not limited to the following:

Work to be sold is made by the artist herself/himself—from start to finish (designed, created, sewn, assembled, etc.)

Scarf and garment blanks are acceptable but must be dyed, embellished, etc. by the artist.

Uniqueness and quality of work.

Vendors who are accepted will be notified no later than February 15, 2016. Refunds of space payment will be made to those not accepted after March 31, 2016.

Once accepted as a vendor, the vendor may not sell nor sublet their space nor sell items by persons who have not applied and have not been juried into the show.

Vendors will be asked to submit one piece of their artwork for the FASA Silent Auction. For tax purposes, the value of this item is tax deductible. FASA will provide a Silent Auction Form to all selected vendors.

Set up of vendors will begin at 8:a.m. on Saturday April 9, and must be completed no later than 9:45 a.m. The sales room will open at 10:a.m. Vendors who do not register with the vendor committee by 9: a.m. will be considered a no show and the vendor committee will determine use of the space. The vendor sales room will be closed during the luncheon and runway presentation, but will reopen immediately after, until 3:p.m. No vendor can begin breaking down their space until 3:p.m. The sales room must be cleared by 4:p.m.

Fiber Artists of San Antonio and the Oak Hills Country Club will not be held liable for any damage or loss of vendor's artwork or display items.

I acknowledge I have read this application carefully and understand and agree to its terms and understand that this is a binding contract with Fiber Artists of San Antonio. I understand that if I do not comply with any of these terms, I will be required to relinquish my vendor space and will not be accepted as a vendor in future FASA events.
