Art on Broadway is an outdoor event for Texas artists to display and sell their art. All artwork must be original and made by the Exhibitor. Non-profit organizations related to art may also purchase a space to be manned by their members.

Applications and images must be submitted or postmarked no later than September 8, 2017. Applications may be hand delivered to: Lions Field Adult & Senior Center, 2809 Broadway, San Antonio, Texas 78209 or sent via email: artonbroadway@gmail.com. *Applicants will be phoned and emailed acceptance no later than September 20, 2017.* Rejections with returned check will be notified by mail.

Fee: \$60 single/\$75 shared booth

- Includes one (1) outdoor exhibitor space and bottled water.
- Exhibitors will have access to the indoor hospitality table for snacks.
- Exhibitors must provide their own table, chairs, tents, etc.
- Booth sharing is permitted but limited to two (2) exhibitors per booth. Co-exhibitors must be listed and submit three images with application.
- *Full payment (cash or check ONLY) must be received with application in order to guarantee a space. Please make checks payable to: Lions Field Council.*

Artwork Standards: All pieces must be original, handmade and signed by the artist. Only work from artists listed on the application are permitted. No mass produced work will be permitted. Work created with pre-printed fabrics, kits or patterns will not be permitted. No sale or discount signage permitted. Permitted reproductions include silk screen, lithography, intaglio, and other hand pulled prints, and signed giclee prints.

Artist Amenities: Booth sitters will be available for up to 15 minutes at a time. Free water through out the day and access to the hospitality table for exhibitors. Indoor restrooms available to exhibitors and patrons. Flat affordable booth fee, no commission. Assistance with unloading and loading. No more than 25 booths.

Booth Space: Booths are located outside on the front lawn. Each exhibitor will have one 10x10 space. Exhibitors must provide their own tents, tables, chairs and display equipment. All materials must be kept within the assigned booth area and cannot extend into neighboring booths. Exhibitors will be permitted to unload in the main parking lot, but must move their vehicle to the side parking lot before 9:45am. No vehicles on the lawn. Exhibitors may begin setting up at 8am. No electricity provided.

Exhibitor agreement

- All displayed work shall be made by the artist or members of an art non-profit organization.
- Artwork must be comparable to submitted images or exhibitor will be asked to remove those items.
- The artist must staff their own booth, no representatives.
- Exhibitor agrees to display a government issued photo ID at check-in (upon request).
- Exhibitor authorizes the City of San Antonio Parks and Recreation Department and the Lions Field Association to use Exhibitor’s images provided in Exhibitor’s application for promotion of past and future events only with no compensation.
- Exhibitor understands that no refunds can be offered for cancellations.
- Exhibitor agrees to remain present and maintain an open exhibition space during event hours and understands that early departure is not allowed.
- Exhibitor is responsible for providing a cash box/change fund, if necessary.
- Exhibitor certifies that its sales will be in full compliance with the Texas Law regarding the collection of sales tax.
- No rain dates or refunds will be offered due to inclement weather. In the event of inclement weather, the event will be moved indoors into the Lions Field Center.
- Exhibitor understands that no insurance is offered or provided to cover injury to Exhibitor or for damage to Exhibitor’s property. Exhibitor is solely responsible for obtaining insurance coverage and shall be liable for damage caused by Exhibitor’s property.

In consideration of Exhibitor being permitted to display and sell artwork at Lions Field Adult & Senior Center, the undersigned hereby releases the City of San Antonio (“City”), its employees, agents and members and the Lions Field Association, its agents and members from any action, claim or demand for personal injury or property loss from or due to any negligent act or omission of the City, its employees, agents and members.

Exhibitor grants City permission to seek immediate medical treatment for Exhibitor in the event of an emergency. Exhibitor agrees to accept full responsibility for the expense of such medical treatment or services.
