



**Call for Entries - Threads of Magic, 45<sup>th</sup> Annual Juried FASA Exhibition**  
October 11, 2019 through November 15, 2019

“**Threads of Magic**”, an exhibition at the University of Incarnate Word in San Antonio, Kelso Art Center.

**Juror:** Sue Benner. An innovator in her field, Benner creates complex dyed and painted textiles combined with recycled fabric to form collaged fields of pattern, color, and beauty. See her website for additional details [www.suebenner.com](http://www.suebenner.com).

**Eligibility:** Show is open to both current members of the Fiber Artists of San Antonio (FASA) and non-members. Each individual may enter three (3) pieces of art for this show. FASA member entry fee of \$30 for up to three pieces. Non-member entry fee will be \$35 for up to three pieces. Artwork must be original and completed after January 1, 2017, and not have been part of a previous Fiber Artists of San Antonio Exhibition. Each piece must be primarily of textile or fiber, but may incorporate other materials. Exhibition is open to wall and ceiling suspended, as well as 3D work. Hanging artwork is not to exceed 60 inches in height or width. All hanging/display apparatus must be included with artwork.

**Entry Format:** Entries will be selected from online Art Call system – [www.fasaentry.org](http://www.fasaentry.org)

**Prizes:** Winning artwork to be selected and awarded by juror at the opening reception.  
1<sup>st</sup>-\$300, 2<sup>nd</sup>-\$200, 3<sup>rd</sup>-\$100, KFLF Beading Award-\$100, FASA Member of Excellence-\$100, Juror Choice-\$100

**Sales:** Artwork cannot be removed during the exhibition. Any sales will be handled UIW with 30% commission to go to UIW. **Insurance:** Covered by University of Incarnate Word while in possession of UIW.

**Shipped Works:** Accepted Artwork, along with any necessary hardware for installation, must be shipped **Fed Ex or UPS w/pre-paid return postage included** to: University of Incarnate Word, Kelso Gallery, 4301 Broadway, San Antonio, Texas, 78209. Artists are responsible for **all shipping and insurance charges** to and from the exhibition site.

**Hand delivered:** Tuesday, October 8 from 10:00am-12noon to the University of Incarnate Word in San Antonio. Please be sure to label your artwork with name, title and phone contact. Be sure to include all hanging hardware.

**Return of Work:**

Pick up at the University of Incarnate Word in San Antonio Monday, November 18, between 10:00am-12noon.
